Cedar River Whitewater Project (moved from above):

Ruzek talked about the proposed Cedar River Whitewater Project and the feasibility study that is needed to see if this project is possible. The total cost of the study will be approximately \$50,000 and Ruzek informed the board of the funding sources available. He has requested approval from Mower County to utilize \$25,000 of the ARPA funding. There would also be \$5000 from the Cedar Wapsi 1W1P grant to add to funding the study. Discussion was held. Peterson made a motion to approve \$25,000 of ARPA funding, along with \$5,000 from the Cedar Wapsi 1W1P grant to help fund the Cedar River Whitewater Project feasibility study.
