Orchard Creek Bids:

The board looked at the 5 bids that were received for the Orchard Creek access. Funding for this project will come from DNR bonding, Hormel Foundation and ARPA. Kellogg made a motion to award Rochester Sand & Gravel with the lowest bid for the project at \$117,209.56. Soltau seconded the motion.
