Moe made a motion to approve the waterway cost share payment of \$13,952.70 for Jennifer Nord, 90% of the total cost of \$15,503.00. Funding for the waterway will come from the FY24/25 Cedar Wapsipinicon WBIF grant. Soltau seconded the motion.

Kellogg made a motion to approve the waterway cost share payment of \$1,421.25 for Jon Stroup, 75% of the total cost of \$1,895.00. Funding for the waterway will come from the FY24/25 Cedar Wapsipinicon WBIF grant. Soltau seconded the motion.

Kellogg made a motion to approve the amendment to the Cedar Wapsi 1W1P cover crop incentive contract #CW22-24-14 for Richard & Wendy Jones. The amendment includes increasing the total 3 year incentive amount from \$15,750.00 to \$18,584.00. Soltau seconded the motion.

Moe made a motion to approve the 2<sup>nd</sup> year cover crop incentive payment of \$6,667.00 for Richard & Wendy Jones. Funding for this project will come from the FY24/25 Cedar Wapsipinicon WBIF grant. Soltau seconded the motion.

#### Health Insurance:

Erichson and Fox explained that, due to an almost 23% increase in the current Medica health insurance through the SE Service Coop, other options were explored. They talked about a new plan through North Risk Partners and explained the differences between their plan and the SE Service Coop. Included with the North Risk Partners package would be a single/family \$1000/\$2000 deductible and \$10,000 out of pocket maximum (\$4600 more than the current plan maximum). An out-of-pocket maximum American Health Resources 105 buy down plan was also explored. See comparison summary below.

The board held discussion on the new options, along with keeping the 15% employee share. Erichson made a motion to go with the new insurance plan through North Risk Partners for 2026. Kellogg seconded the motion.

#### PFML:

Fox and Erichson talked about the Paid Family & Medical Leave Program, a mandated MN state program. This program covers employees and board members. The cost of this program through the state is .66% of covered wages for small employers. Fox checked into an equivalent plan through ShelterPoint Insurance Company, of which, the cost is .59%. Erichson made a motion to go with the ShelterPoint Insurance for PFML at .59%. The cost of the PFML will be split 50/50 between the SWCD and employees. Soltau seconded the motion.
